1. Review of expenditure	
Previous Academic Year	2015/16

In the 2015-16 academic year, 10 out of the 12 pupil premium pupils made their expected progress or more in reading, 11 in writing and 11 in maths. This data shows that the gap between the progress and attainment of pupil premium pupils and that of others has continued to narrow. The effective allocation of pupil premium funding has had a positive impact on outcomes for those pupils.
